Dear Players

Auckland Badminton is now in the process of planning for Senior Inter-Association competition for the 2013 season. We are currently seeking expression of interest from anyone who would like to represent Auckland in senior division for the 2013 season so we can begin the trialling and selection process early.

For 2013 Auckland has entered four senior division teams: Division 1 (Wisden Cup) 2 teams, Division 3 and Division 4.

2013 dates to consider before committing:

1. Wisden Cup: Tuesday 13th - Saturday 17th August

Venue: Waitakere

2. Division 3 and 4:

First tie - Saturday 20th April (Div 3 Whangerei, Div 4 Waitakere) Second tie - Saturday 25th May (Div 3 Hawkes bay, Div 4 Waikato) Third tie - Saturday 6th July (Div 3 Waikato, Div 4 North Harbour) Fourth tie - Saturday 3rd August (Div 3 Wanganui, Div 4 Manakau) Finals (Div 3 only if qualify) -Saturday 14th September

3. Trials: Saturday 16^{rd} March 9-12pm & Sunday 17^{th} March 1-4pm (if required)

4. Pre-season training: There will be no pre-season training scheduled for 2013 due to

lack of numbers participating in last 2 years.

There will be training assigned to the Division 3 and 4 teams two weeks prior to each Division tie. Training dates are: Sundays 4-6pm and will possibly have a coach at sessions depending on demand: 7^{th} April and 14^{th} April, 18^{th} March and 25^{th} March, 12^{th} May and 19^{th} may, 23^{rd} June and 30^{th} June.

Wisden teams will have set training days and times 8-10 weeks before the competition begins. Players if selected will be expected to cover all costs for their team entries/shuttles/uniforms/trainings and travel expenses. Auckland Badminton if able to may provide sponsorship for part of these costs.

ELIGIBILITY - ALL DIVISIONS

- All Inter-Association players must be registered full members of an ABA Member Club by March 1st 2013.
- All players are required to participate in 2013 ABA Interclub competition played weekly from April or the Premiere A grade competition. Auckland Elite and Emerging Squad players may be exempted if it is obvious to the Selectors that participation would not be beneficial to any individual player or fit into their current training load.
- All players must attend the trial date including all Wisden players, exceptions must be sort from the coaching manager prior to trials.
